



Electric Vehicle Offer – ELIGIBILITY CONDITIONS

The only persons eligible for the Electric Vehicle Offer from Intact Insurance Company (the “**Insurer**”), are new automobile insurance policyholders of the Insurer who are residents of Quebec and who purchase an automobile insurance contract to insure one or more **all-electric** or **plug-in hybrid** vehicles as defined in the Insurer’s underwriting guidelines and used for private purposes (vehicles in classes 1 to 22 only) (the “**Designated Vehicle(s)**”), on or after April 1, 2015.

The Offer includes the following features:

- a discount of 20% applicable to the entire insurance premium for a Designated Vehicle, and;
- depending on the type of insurance contract purchased by an eligible person, one or more Memberships in the Association des Véhicules Électriques du Québec (“**AVÉQ**”), paid for by the Insurer, as described below.

The following are eligible for the 20% electric vehicle discount only:

- new automobile insurance policyholders of the Insurer whose premium for a Designated Vehicle on their new insurance contract was rated between February 22, 2015 and March 31, 2015; and
- existing automobile insurance policyholders of the Insurer who make an addition or substitution of a risk and whose new risk is a Designated Vehicle rated on or after February 22, 2015 at 11:59 p.m., in which case the electric vehicle discount will apply only to this new risk.

Terms and conditions of AVÉQ Membership

For a personal or business insurance policy covering one or more Designated Vehicles (with the exception of an automobile fleet policy): for each principal operator of a Designated Vehicle, identified as such by an eligible person, who acquires or renews an annual membership in AVÉQ (“**Membership**”), the Insurer undertakes to pay to AVÉQ the amount of \$44, representing the Membership fees. Limit of one Membership payment per principal operator and one Membership payment per Designated Vehicle.

For a business insurance policy covering Designated Vehicles that are part of an automobile fleet: each eligible person who purchases an automobile insurance contract to insure Designated Vehicles in a commercial fleet may identify one individual to receive the Membership. The Insurer undertakes to pay to AVÉQ the amount of \$44, representing the Membership fees, for each designated person who completes the Membership process. Limit of one Membership payment per eligible person.

To receive the Membership, the principal operator or designated person, as the case may be, must go to the microsite provided by AVÉQ, at the Internet address which will be communicated to that person in a letter from the Insurer and AVÉQ, and must complete the online Membership form, including his or her surname, given name(s) and email address and the policy number of the insurance covering the Designated Vehicle(s).

The Insurer will pay AVÉQ only for Memberships for which a form is properly completed during the initial term of the insurance contract covering the Designated Vehicle.

Further, the Membership fees will be paid by the Insurer only if the insurance contract covering the Designated Vehicle is in force when the form is completed.

The Electric Vehicle Offer may be amended by the Insurer at any time without notice.
